

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

ELIGIBILITY: The Cummins Westport Trip Sweepstakes (“Sweepstakes”) will begin on August 16, 2018, at 12:01 a.m. Eastern Standard Time (“EST”) and end on September 17, 2018 at 11:59 p.m. EST (“Sweepstakes Period”). The time shall be determined by Sponsor’s timekeeping systems, and Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

The Sweepstakes is open to (i) legal residents of the U.S. (including D.C.) or Canada (excluding Quebec); (ii) who have received the email invitation to participate (the “Invitation”); and (iii) who are at least 21 years old as of the date of entry. Void where prohibited. Employees of Cummins Westport, Inc. (“Sponsor”), PriceWeber Marketing and Communications, Inc. TO ENTER: No purchase necessary. *There are two (2) separate “Entry Pools” for this Sweepstakes:* one Entry Pool for eligible entries received by the September 1, 2018 RSVP deadline, and one Entry Pool for eligible entries received by the September 17, 2018 RSVP deadline.

To enter the Sweepstakes, you must have received the Invitation to participate and complete the following steps:

- RSVP to their specific Invitation by sending an email no later than: (i) September 1, 2018 for Invitations indicating such deadline; or (ii) September 17, 2018 for Invitations indicating such deadline;

WINNER SELECTION: On or about October 8, 2018 at 11:59 p.m. EST, after the conclusion of the Sweepstakes Period, Sponsor will conduct one (1) random drawing from among all eligible entries received during the Sweepstakes Period for each Entry Pool and select one potential (1) winner for each Entry Pool. The selection of potential winners will take place at the Sponsor’s offices at 432 Washington St., Columbus, Indiana 47201.

The selected potential winners are subject to verification of eligibility and compliance with these Official Rules. Limit one (1) prize per person and per household.

Odds of winning will depend upon the number of Invitations sent by Sponsor as well as the number of eligible entries received in each Entry Pool.

 - Access to Sponsor's suite at the racetrack.
